1. The Electricity Supply Corporation of Malawi Ltd has budgeted resources in Financial Year 2017-2018 towards the cost of implementing various programmes in the Transmission Division and it intends to apply part of the funds towards payments under Contracts for the Supply and Delivery of Transmission Materials.
2. The Chairperson, Internal Procurement Committee, now invites sealed bids from eligible and qualified bidders for the supply and delivery of the following:

Lot 1 (a)	132kv Polymer Insulators
Lot 1 (b)	66kv Polymer Insulators
Lot 2 (a)	132kv Steel Cross Arms
Lot 2 (b)	66kv Steel Cross Arms

Qualification requirements include a minimum of three (3) years in the overall experience of the Supplier in the supply of similar goods.

3. Bidding will be conducted through National Competitive Bidding (NCB) procedures specified in accordance with the Public Procurement Act 2003 and the Public Procurement Regulations 2004 of the Government of the Republic of Malawi and are open to all eligible bidders.
4. Interested bidders may obtain further information and inspect the Bidding Document from the Procurement Unit at the address given at paragraph 8(a) below from 08.00 to 12.00 and 14.00 to 16.00 hours local time (Monday to Friday, except national public holidays).
5. A Bidding Document in the English Language may be purchased by interested bidders at the address 8(a) below upon payment of a non-refundable fee of **MWK200,000.00** or equivalent at the address at 8(b) below. The method of payment will be in Malawi Kwacha or equivalent, either in cash or a bank certified cheque.
6. Bids must be delivered to the Tender Box at address at 8(c) below on or before **26th January, 2018 at 14.00 hours** local time. Electronic bidding will not be permitted and Late Bids will be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address 8(d) below on **26th January 2018 at 14.00 hours** local time.
7. Bids must be accompanied by a Bid Security of MWK5,000,000.00 or equivalent; or a Bid Securing Declaration Form if the Bidder is 100% owned by Malawian Nationals. The Bid Security must be in form of a Bank Certified Cheque or Bank Guarantee issued by a reputable bank agreeable to the Purchaser.
