(i) Name of the Minerals: Uranium, Coal, Ruby, Sapphire, Gemstones, phosphate limestone, ceramic clays and salt.

(ii) (a) to (c) - Paladin Kayelekera Uranium Mine, Mchenga Coal Mine, Eland Coal Mine, Mkango Resources, Globe Metals & Mining, Nyala Ruby & Sapphire mine, phosphate in Phalombwe Dist., Shyona Cement, Surestream Petroleum, RAK Gas, SacOil Holdings, Mota Engil Minerals & Mining, Ras Al Harma and Kisikizi Coal Mines etc.

(iii) Since, the information on minerals has been provided above, it is believed the raw materials/products mean agricultural products. Among agricultural products, tobacco, tea, cotton, coffee and sugar are the cash crops in Malawi which earn 80% of foreign exchange earnings. Besides, there is Maize which is staple food in Malawi and Sorghum, millet, pulses, root crops, and fruit are also grown.

(iv) Malawi is a land-locked country and it does not have any sea-ports:

(v) There is Kamuzu International Airport in Lilongwe, the capital and Chileka International Airport in Blantyre, the commercial city.

(vi) **Population**

a) Male – 9,225,153

b) Female – 9,396,951

c) The official language in Malawi is English. While the major languages include Chichewa, a language spoken by over 57% of the population, Chinyanja (12.8%), Chiyao (10.1%), and Chitumbuka (9.5%) according to the National Statistics Office, Malawi.
