## GENERAL PROCUREMENT NOTICE

The Government of the Republic of Malawi intends to apply for financing in the amount of **US\$ 115 Million** equivalent from the International Development Association (IDA) toward the cost of the Lilongwe Water and Sanitation Project and it intends to apply part of the proceeds to payments for goods, works, related services and consulting services to be procured under this project.

*The project will include the following components:*

- i) Component 1—Water Production Expansion
- ii) Component 2—Network Rehabilitation, Expansion and NRW Reduction.
- iii) Component 3—Priority Sanitation Improvements.
- iv) Component 4—Technical Assistance.
- v) Component 5—Institutional Capacity Strengthening.

including groundwater exploratory drilling.

- vii) Consultancy to develop Standard Operating Procedures for Lilongwe Water Board.
- viii) Development and Implementation of Customer Services Improvement Plan including Customer Communication and Branding.

### c) Non-Consultancy Services

- i) Design and piloting of Incentive Based Performance Management System.

Procurement of contracts financed by the World Bank will be conducted through the procedures as specified in the World Bank's Procurement Regulations for IPF Borrowers, July 2016 (Procurement Regulations), and is open to all eligible bidders as defined in the regulations.

Specific procurement notices for contracts to be bid under the World Bank's open-international procedures will be announced, as they become available, in UN Development Business, daMarket, LWB website and in local newspapers.

Works and Services to be procured under Open-International bidding procedures are as follows:

**a) Works**

- i) Priority Network Rehabilitation in Lilongwe City (Distribution pipes, Transport pipes and Installation of Pressure Reducing Valves).
- ii) Priority Network Improvement in Lilongwe City – Construction of Service Reservoirs and Pumping Stations.
- iii) Priority Lilongwe City Sewerage System Rehabilitation, and Expansion and Upgrading of Kauma Wastewater Treatment Plant.
- iv) Water Supply Network Expansion in Lilongwe City (Distribution pipes, Transport pipes, Reservoirs and Pumping Stations).

**b) Consultancy Services**

- i) Detailed Design and Construction Supervision of Network Rehabilitation and Expansion and Packaging of a Performance Based Non-Revenue Water Reduction Program.
- ii) Preparation of a Water Supply Master Plan for Lilongwe City.
- iii) Consultancy Service for Development of a Sanitation Master Plan for Lilongwe City and Design of Priority Sanitation Interventions.
- iv) Construction Supervision of Sanitation Priority Improvements – Sewerage
- v) Revenue Collection Mechanisms Study and Operationalization of Sanitation Tariff.
- vi) Consultancy Services for Groundwater Assessment and Mapping,
