1. The Malawi Government has received a grant from KFW and it intends to apply part of the proceeds to payments for goods, works, related services and consulting services to be procured under this Project.

The Local Development Fund intends to apply part of these resources for payment of the Contract for Supply and delivery of Tractors and Trailers under NCB Contract No: LDF/KFW/2017/1

3. Bidding will be conducted through the National Competitive Bidding (NCB) procedures specified in the Government of Malawi Procurement Guidelines. – ODPP.

Qualifications requirements include: Five (5) years of experience in supplying similar goods, List of Contracts with their values performed in the past three (3) Years , audited financial statements for three (3) years, availability of local agent in case of bidders who are not doing business in the purchaser's country. A margin of preference for eligible national bidders "shall not" be applied. Additional details are provided in the Bidding Documents.

5. A complete set of Bidding Documents in English may be purchased by interested bidders to the address (1) below and upon payment of a non-refundable fee of MK3,500.00 (Three Thousand Five Hundred Kwacha only) or in USD \$25 equivalent.

The method of payment will be cash or bank certified cheque and a General Receipt will be issued for all payments from the Cash or bank certified check. The Bidding Documents will be collected by bidder immediately upon payment or be sent by express mail or courier in which case the applicant/bidder should clearly indicate the delivery address and bear the costs.

6. Bids must be delivered to the address below (by depositing in a Tender Box located on the ground floor near reception at or before 15:00 hours Local Time on 28th April, 2017. Electronic bidding will not be permitted. Late bids will be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend in person at the address (3) below at 15:00 hours Local Time on 28th April, 2017 in the Conference Room. All bids must be accompanied by a Bid Security of at least 2% (Two Percent) of the total bid value.
