1. This invitation for bids follows the General Procurement Notice (GPN) for this project that appeared in United Nations Development Business online (UNDB Online) No. AFDBB06-04/12 of 10th April 2012 and on the African Development Bank's Website (www.afdb.org).
2. The Government of Malawi has received a loan from the African Development Fund (ADF) in various currencies towards the cost of the Competitiveness and Job Creation Support Project (CJCSP) which is being coordinated by the Ministry of Industry, Trade and Tourism. It is intended that part of the proceeds of this loan will be applied to eligible payments under the contract for Supply, Delivery and Installation of agro processing machines for soy bean/ sun flower cooking oil at selected warehouses across three regions of the country.
3. The Ministry of Industry, Trade and Tourism through the Competitiveness and Job Creation Support Project now invites sealed bids from eligible bidders for supply, delivery and installation of the following agro processing machines:

Bidding will be conducted in accordance with **National Competitive Bidding (NCB)**

Procedures contained in the Bank's Rules of Procedure for Procurement of Goods and Works.

4. Interested eligible bidders may inspect the bidding documents at the CJCSP Project Secretariat at the address given below under paragraph 10 from 09:00 am to 12:00 noon and from 1:30 pm to 4:30 pm from Monday to Friday except on public holiday from 21 July 2017.
5. A complete set of Bidding Documents in English Language may be purchased by interested bidders from the address given in paragraph 10 upon payment of non-refundable fees of Six Thousand Malawi Kwacha (MK6, 000.00). The method of payment is cash or bank Certified Cheque.
6. Provisions in the Instructions to Bidders and in the General Conditions are those of the Bank's Standard Bidding Document for Procurement of Goods.
7. Bids must be delivered to the address below under paragraph 11 and must be deposited in a Tender Box marked "**Procurement of soy bean/sun flower cooking oil Processing Machines - PU-012/06/MOITT/CJCSP/06-2017**" that is placed at the Reception Area in Gemini House, Floor Number 3, at or before 14:00 hours local time on or before Monday 21 August 2017 and must be in a sealed envelop marked outside "**Bidding Documents for Procurement of Agro Processing Machines**". Late bids will be rejected.
8. Bids shall be valid for a period of **90 days** from the date of bid opening and must be accompanied by a duly completed **Bid Securing Declaration**.
