In the case of dispatching by mail or any other mode, NOCMA cannot be held responsible for non-receipt of the documents by the bidder. Upon request NOCMA may send a copy by electronic mail system.

Bids in sealed envelopes must be delivered to the address below at or before **14:30 hours on 6th November, 2017**. All bids must be accompanied by a bid bond of **US\$2,800,000.00 (Two million eight hundred thousand United States Dollars)**. Late bids will be rejected. Bids will be opened at **14:30 hours on 6th November, 2017** at the buyers address, in the presence of bidders representatives who choose to attend.

Bidders are at liberty to bid any combination of Ports or products.

NOCMA reserves the right to accept or reject any bid and may annul the tender process or reject all bids altogether without giving reason, and without thereby incurring any liability to any Bidder or Bidders, and NOCMA shall not be under any obligation to subsequently inform any Bidder or Bidders of the grounds for NOCMA's action.

This tender is for a **90-day** credit period as detailed in the Tender Document, irrespective of fluctuations in the global fuel price during the period of the supply contract.
