# Addendum to the tender for the Supply, Delivery, Installation and Commissioning of Incinerators

Interested bidders are informed on the addendum to the submission date of the tender for supply, delivery, installation and commissioning of Incinerators. This has been necessitated by the urgent need to provide further clarifications to queries raised by bidders which has now been provided.

1. The Ministry of Health has budgeted resources from Global Fund in the Financial Year 2017-18 towards Safe disposal of pharmaceutical grade which is a major challenge in Malawi. Currently pharmaceutical disposal is carried out using methods that have proved to be hazardous to public health. For instance, landfills which present with possibility of leachates entering the aquifer and drinking water system, while open air burning at low temperatures results in release of toxic pollutants into the air.
2. The Ministry with support from Global Fund seeks for the service providers to **Supply, Delivery, Installation and Commissioning of Pharmaceutical upgrade Incinerators.**
